

Dear Sir,

The tender for the work of "Repairing and maintenance of qtr. No. 225 at Prem Nagar Colony and qtr. No. 235 at Kharkhari Govindpur under Katras Area" was invited vide e-NIT Ref. GM/KA-IV/Civil/eNIT/21-22/36; dated: 02.09.2021. While scrutinizing the confirmatory documents of yours, it was found that there were some alterations with the Annexure II of undertaking and accordingly you were asked to re-submit the same in the format given in the NIT. In the re submission of the Annexure II, the same format was uploaded by you again which is not acceptable as per NIT which changes the eligibility status of the bidder.
