(i) The work "Dismantling and laying of G.I. pipe line at Durga Nagar Colony at Coal Dump colony under Katras Area" was invited vide e-NIT Ref. GM/KA-IV/Civil/eNIT/21-22/41 ; dated: 23.09.2021.

(ii) The work was awarded to you vide LOA Ref. BCCL/GM/KA-IV/CIVIL/LOA/2021-22/2715 Date: 01.02.2022 for Rs. 2,52,421.46 (Rupees Two lakh fifty-two thousand four hundred twenty-one and forty-six paise only)(excluding GST) at overall (-)25.50% (Twenty-five point five zero percentage) below the estimated cost of work.


(iii) As per terms of NIT/ Tender documents and LOA, You were asked to deposit Rs. 7573.00 (Seven Lakh five seventy-three only) towards Performance Security within 21( Twenty-one) days from the date of issue of the "Letter of Acceptance" in the form as indicated at clause 4.2 of "General Terms & Conditions" of the bid document to facilitate issue of work order & execution of agreement.

(iv) As per LOA you were to deposit the Performance Security on or before 22.02.2022. However, you have not deposited the PSD money yet and failed to deposit Rs. 7573.00 (Seven Lakh five seventy-three only) within 21 (Twenty-one) days from the date of issue of the "Letter of Acceptance.

- (v) In view of the above, the following actions are invoked against you as per clause 4.2 (Condition of Contract ) of NIT: GM/KA-IV/Civil/eNIT/21-22/14 ; dated: 24.06.2021.
- c. Rescinding the LOA awarded to you vide LOA ref. BCCL/GM/KA-IV/CIVIL/LOA/2021-22/2715 ; Date: 01.02.2022
- d. You are banned for two years from being eligible to submit bids in CIL and its subsidiaries.
