1. The tender for the work of "Repair and maintenance of two classroom and other civil works of D. A. V. public school under Kusunda Area "was invited vide eNIT Ref. BCCL/Kus.A.6/Civil/eTender/2020-21/82 Dt. 31.03.2021.
2. The work was awarded to you vide LOA Ref. no. BCCL/GM/Kus.A-VI/Civil/LOA/21-22/17 Date: 07.09.2021 for Rs. 158512.76/- (Rupees One lakh fifty eight thousand five hundred twelve and seventy six paisa only) which is 37.99% below of the Estimated Cost of work.
3. As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs 4755/- (four thousand seven hundred fifty five only) towards performance security within 28 Days from the date of issue of the "Letter of Acceptance " in the form of as indicated at clause no. 3.1 of Bid Security Declaration of the Bid document to facilitate issue of detailed work order, failing which the work shall be cancelled with banning of bidder for two years and not being eligible to submit the bids in CIL & its subsidiaries.
4. As per LOA you were supposed to deposit the Performance security on or before Dt 05.10.2021, However there was no response from your side regarding the deposition of Performance Security as per LOA.
5. As you failed to deposit Rs 4755/- (four thousand seven hundred fifty five only) towards Performance security within 28 Days from the date of issue of the "Letter of Acceptance" , the following action are invoked against you as per Clause 3.1 (Condition of Contract) of NIT.

- b. Banning for two years from being eligible to submit bids in CIL and its subsidiaries.
