1. The tender for the work of "Construction of Precast RCC Boundary wall for 294 mtr overlain with concertina wire fencing at ENA Coal dump under Kusunda Area" was invited vide eNIT Ref. BCCL/Kus.A.6/Civil/eNIT/ 2022-23/22 Dt. 10.08.2022.
2. The work was awarded to you vide LOA Ref. no. BCCL/GM/Kus.A-VI/Civil/ WO/22-23/43 Date: 03.12.2022 for Rs 579982.70 /- (Five Lakh Seventy nine thousand Nine hundred eighty two only) which is 16.19% below of the Estimated Cost of work.
3. As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs 4755/- (four thousand seven hundred fifty five only) towards performance security within 28 Days from the date of issue of the "Letter of Acceptance " in the form of as indicate at clause no. 3.1 of Bid Security Declaration of the Bid document to facilitate issue of detailed work order , failing which the work shall be cancelled with banning of bidder for two years from banning eligible to submit the bids in CIL & its subsidiaries.
4. You had not commenced the work within the aforesaid time limit. As per Clause of NIT "6. Time for Completion of Contract, Extension thereof, Defaults and Compensation for Delay
6.1 If the contractor, without reasonable cause or valid reasons, commits default in commencing the



5. work within the aforesaid time limit, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 day's notice in writing to the contractor to commence the work, failing which to forfeit the Earnest Money deposited by him and to rescind the Letter of Acceptance of Tender/Work Order and also to ban the contractor to take part in the future re-tender.


The bidder shall be banned for two years from being eligible to submit bids in CIL and its subsidiaries. This banning shall be done under the provisions of NIT with the approval of Tender Accepting Authority by Application Admin of CIL e-Procurement Portal."

6. As such, the work order awarded to you vide work order Ref no. **BCCL/GM/Kus.A-VI/Civil/WO/22-23/43** Date: **03.12.2022** is hereby cancelled.

- b. You are banned for two years from being eligible to submits bids in CIL and its subsidiaries.
