Dear Sir

- (i) The work of "Repair and Maintenance of Transit House D-6 , Sector- X and renovation of Bathroom of DB No-03" was tendered vide NIT ref. no. BCCL/CED-KNTA/Tender/20-21/e-NIT-16; dated 05.12.2020.
- (ii) The above work was awarded to you vide LOA ref. no. BCCL/KNTA/LOA/2020-21/25; dated 13.03.2021 at a value of Rs. 2,07,388.94 Rupees Two lakh seven thousand three hundred eighty eight and paisa ninety four only) at overall 43.62 % (Forty Three point Six Two percent) below the estimated cost.
- (iii) As per terms of NIT /Tender documents and LOA, you were asked to deposit Rs. 1,60,710.00 (Rupees one lakh sixty thousand seven hundred ten only) towards Additional Performance Security Deposit(APSD) and Rs.10,370.00 (Rupees ten thousand three hundred seventy only) towards Balance amount of Performance Security within 28 (twenty eight) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.
- (iv) However you failed to deposit the Additional Performance Security and Balance amount of Performance Security as per LOA within the stipulated time period of 28 days.
- (v) Further you were requested several times to deposit the Additional Performance Security and Balance amount of Performance security through various letters as detailed below :

 - e. Final Notice BCCL/CED/ KNTA/68 dated 03.06.2021
- (vi) As there was no response from your side despite of various reminders issued by the department, the work/contract awarded to you terminated vide letter ref. BCCL/CED/GM(C)/KNTA/2021-22/212; dated: 17.09.2021, along with forfeiture of Bid Security/EMD of Rs. 4,600.00 (Rupees Four Thousand Six hundred only) and Penalty of Rs 36,766.45 as per clause of 10 of NIT. Further you were banned from participating the retendering process for violating the terms and condition of NIT as per clause 4.2 (Condition of Contract), 4.8(Condition of Contract) and 6.1(Condition of Contract) of NIT.
- (vii) You are hereby banned from participating in future tenders of BCCL for a period of 12 months from date of issuance of this letter.
