(ii). The above work was awarded to you vide LOA Ref. No. GM/C.V /AR-XII/ACE/LOA/2021-22/1399 Dated:-12 .10.2021 at a value of Rs. 1,10,524.42 (Rupees One Lac Ten thousand five hundred twenty four and paisa forty two only ) which is -26 % (Minus Twenty six percentage) below the estimated cost.

(iii). As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs. 3,316.00 (Rupees Three thousand three hundred sixteen only) towards performance security money within

21 (twenty one ) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.

(iv). You were requested several times to commence the work as well as to deposit the Security money but you have failed to deposit the Security money in time. Details of Correspondence/e-mails as mentioned below:

(vi) Additionally the following penal actions are invoked against you :

- b). You are debarred from participating in future tenders in CIL & its Subsidiaries for a period of (Two) Years from the date of issue of this letter.
