
1. The work of "Repairing of drinking water supply pipe line for day-day maintenance of different Qtrs. Of different Colonies of Bhowra for F.Y. 2021-22 under E.J. Area".
2. The above work was awarded to you vide LOA No. GM/EJA/ACE/LOA/2021-22/997, dt:28.12.2021 at a value of Rs.5,24,565.76 (Rupees five lakh twenty four thousand five hundred sixty five and paise seventy six) only which is (-)24.99% ( twenty four point nine nine percent) below the estimated cost.
3. As per LOA, you were to deposit the performance security on of before 18.01.2022. However there was no response from you side regarding the deposition of Performance Security as per LOA.
4. As per terms of NIT / Tender documents and LOA , you were asked to deposit Rs. 13,337.00 (Rupees **thirteen thousand three hundred thirty seven**) only towards performance security within 21 (twenty on) days of the issue of the Letter of Acceptance" in the form as indicated at clause No. 4.2 of "General Terms & Conditions" of the bid documents to facilitate issue of the work order and execution of agreement.
5. Since, there was no response from your side. Therefore, another letter was given to you vide Ref. No. BCCL/CIVIL/EJA/2022/51, dt:18.01.2022, as a last chance for submitting and depositing performance security money amounting to Rs.13,337.00 within 10 (ten) days issue of this letter. But again there was no response from your end.
6. Therefore, the work awarded to you is cancelled for violating the Terms & Conditions of NIL as Per clause 4.2.

You are banned for two years from being eligible to submit bids in CIL and its subsidiaries.
