1.(i). The work of "Repairing & Maintenance work in EDP Room and Aluminium Partition Wall in Begunia Project Officer' s Room ,under C.V Area."was tendered vide Ref. No. BCCL/XII/ACE/e-Tender-47/2021-22/1127 Date:06.08.2021

(ii). The above work was awarded to you vide LOA Ref. No. GM/C.V /AR-XII/ACE/LOA/2021-22/1583 Dated:-18 .11.2021 at a value of Rs. 91,335.22 (Rupees Ninety One thousand three hundred thirty five and paisa twenty two only) which is -10 % (minus 10 percentage) below the estimated cost.

(iii). As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs. 2,740.06 (Rupees Two thousand seven hundred forty and paisa zero six only) towards performance security

money within 21 (twenty one) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.

iv). You were requested several times to commence the work as well as to deposit the Security money but you have failed to deposit the Security money in time. Details of Correspondence/e-mails as mentioned below:

(vi) Additionally the following penal actions are invoked against you :

- a). You will not be allowed to participate in the retendering process.
- b). You are debarred from participating in future tenders in CIL &its Subsidiaries for a period of (Two) Years from the date of issue of this letter.
