1. (i). The work of "White Washing/Paint with tiles flooring at Laikdih Dispensary, under C.V Area." was tendered vide Ref. No. BCCL/XII/ACE/e-Tender-33/2021-22/955 Date:01.07.2021
2. (ii). The above work was awarded to you vide LOA Ref. No. GM/C.V /AR-XII/ACE/LOA/2021-22/1413 Dated:-19 .10.2021 at a value of Rs. 1,39,622.15 (Rupees One lac thirty nine thousand six hundred twenty two and paise fifteen only)) which is 10 % (Ten percentage) below the estimated cost.
- (iii). As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs. 11,171.00 (Rupees Eleven thousand one hundred seventy one only) towards performance security money within 21 (twenty one) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.

(v) Also a email is received from your official e mail id regarding Non Acceptance of our LOA citing the reason being increase in inflation (Copy enclosed).


(vi) As there was no response from your side despite of various reminders issued by the department, also your unwillingness to accept the LOA citing the reason being increasing vide letter No. Nil date.19.11.2021,hence in view of above circumstances work awarded to you stands cancelled for violating the terms and condition of NIT as per clause 4.2 (Condition of Contract), 4.8 (Condition of Contract), 6.1 (Condition of Contract) and 20.2 (Instruction to bidder) of NIT.

(vii) Additionally the following penal actions are invoked against you :

- a). You will not be allowed to participate in the retendering process.
- b). You are debarred from participating in future tenders in CIL & its Subsidiaries for a period of (Two) Years from the date of issue of this letter.
