- 1) The work of "Repairing and maintenance of quarter number D-02 at Harina Colony under Barora Area" was awarded to you vide LOA ref No. GM/Ar-I/Civil/LOA/21-22/01/505 Date: 03.07.2021 at a value of Rs. 4,18,852.00 (Rupees four lakhs eighteen thousand eight hundred fifty two only) at overall (-) 31.39% below the estimated cost.
- 2) As per terms of NIT/ Tender documents and LOA, You were required to deposit Rs. 10,650.00 as Performance Security Deposit (PSD) within 28 days.
- 3) However, you failed to deposit the Performance Security Deposit (PSD) within stipulate time period of 28 days.

 - You will not be allowed to participated in the future retendering of this work.
 - You are banned for two years from being eligible to submit bids in CIL and its subsidiaries.
