- (i) The tender for the work of "Construction of Septic tank for for D type, Sector- V including HIRAK CLUB, Sector-V in Koyla Nagar(for 300 users)" was invited vide e NIT Ref. BCCL/CED/TC/eNIT-22/2020-21/1014; Date: 24.03.2021.
- (ii) The work was awarded to you vide LOA Ref. BCCL/CED/TC/LOA-07/2021-22/311; dated: 05.08.2021 for Rs. 9,31,859.15 (Rupees Nine lakh thirty one thousand eight hundred fifty nine and paise fifteen only) at 23.23% (Twenty three point two three percentage) below the estimated cost of work.
- (iii) As per terms of NIT /Tender documents and LOA, you were asked to deposit Rs. 27,956.00(Rupees Twenty seven thousand nine hundred fifty sixonly) towards Performance Security within 21 (twenty one) days from the date of issue of the "Letter of Acceptance" in the form as indicated at clause 4.2 of "General Terms & Conditions" of the bid document to facilitate issue of work order & execution of agreement.
- (iv) As per LOA you were to deposit the Performance Security on or before 26.08.2021. However , you submitted the Performance Security on 03.09.2021 , vide FDR Ref. No. 101040, Acc No. 08191400004312; dated: 02.09.2021 for Rs.28,000.00 only, issued by Punjab & Sindh Bank, Kusum Vihar, Dhanbad.

- (v) As you failed to deposit Rs. 27,956.00(Rupees Twenty seven thousand nine hundred fifty six only) towards Performance Security within 21 (twenty one) days from the date of issue of the "Letter of Acceptance, the financial instrument submitted by you in the form of FDR vide Ref. No. 101040, Acc No. 08191400004312; dated: 02.09.2021 for Rs.28,000.00 only, issued by Punjab & Sindh Bank, Kusum Vihar, Dhanbad , was returned to you through a letter vide ref. BCCL/CED/GM(C)/2021-22/546; dated: 28.09.2021 and you were informed that the matter will be dealt as per terms and condition of NIT.
- (vi) In view of the above , the following actions are invoked against you as per clause 4.2 (Condition of Contract) of NIT :
- Cancellation of the LOA awarded to you vide LOA ref. BCCL/CED/TC/LOA-07/2021-22/311; dated: 05.08.2021
 - You are banned for two years from being eligible to submit bids in CIL and its subsidiaries.


