(i). The work of "Cleaning of Colony Ash, Garbage, Rubbish including Drains & Road sweeping at D.R Colony, under C.V Area (06 Months) ." was tendered vide Ref. No. BCCL/XII/ACE/e-Tender-08/2021-22/826 Date: 21.05.2021

(ii). The above work was awarded to you vide LOA Ref. No. GM/C.V /AR-XII/ACE/LOA/2021-22/1014 Dated:- 21 .07.2021 at a value of Rs. Rs. 141885.54 (Rupees One lac forty one thousand eight hundred eighty five and paisa fifty four)) which is 6.80 % (Six point eighty percentage) below the estimated cost.

(iii). As per terms of NIT/Tender documents and LOA , you were asked to deposit **Rs. 4256.57** (Rupees Four thousand two hundred fifty six and paisa fifty seven only) towards performance security money within 21 (twenty one) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.


