Dear Sir,

(i). The work of "Roof Grading with Cement Concrete over D3 type Qtr. at R.S. Colony, under C.V Area" was tendered vide Ref. No. BCCL/XII/ACE/e- Tender-02/2021- 22/854 Date: 26.05.2021.

(ii). The above work was awarded to you vide LOA Ref. No. GM/C.V /AR-XII/ACE/LOA/2021- 22/1002 Dated:- 16.07.2021 at a value of Rs. 78950.86 (Rupees Seventy eight thousand nine hundred fifty and paise eighty five) which is 10 % (Ten percentage) above the estimated cost.

(iii). As per terms of NIT/Tender documents and LOA , you were asked to deposit Rs. Rs. 2368.53 (Rupees Two thousand three hundred sixty eight and paise fifty three only) towards performance security money within 21 (twenty one ) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.

(iv). However you failed to deposit the performance security as per LOA within the stipulated time period of 21 days.

(v). You were requested several times to deposit the performance security through various letters as well as emails as detailed below:

- a. LOA issued via dispatch no. 1002 dated 16.07.2021.
- b. Email sent on 17.07.2021.
- c. First Reminder on 30.07.2021 via email.
- d. Letter sent through email 02.08.2021
- e. Letter sent through email 11.08.2021.
- f. Final Reminder vide Ref. No. BCCL/XII/GM/CV/Om/Site handover/21-22/1186 Dated :-13.08.2021.

(vi) As there was no response from your side despite of various reminders issued by the department, the work awarded to you stands cancelled for violating the terms and condition of NIT as per clause 4.2 (Condition of Contract), 4.8 (Condition of Contract), 6.1 (Condition of Contract) and 20.2 (Instruction to bidder) of NIT.


(vii) Additionally the following penal actions are invoked against you :

a) You will not be allowed to participate in the retendering process.
