4. Hence as per NIT clause No.13.e in case the L-1 bidder fails to submit requisite document online as per NIT or if any of the information/declaration furnished by L-1 bidder online is found to be wrong by tender

Committee during evaluation of scanned documents uploaded by bidder, which changes the eligibility status of the bidder, then his bid shall be rejected and the bidder will be banned for two years from being eligible to submit bids in CIL and its subsidiaries. This banning shall be done

under the provision of NIT with the approval of tender accepting authority by application Admin of CIL e-Procurement portal. (In case of a JV/Consortium all partners will be banned.

5. Additionally the following penal action are invoked against you as per Clause 13.e of NIT:

- a. You will not be allowed to participate in the retendering process from the date of issue of this letter.
- b. You are debarred from participating in future tenders in CIL & its Subsidiary for a period of 2(Two) years from the date of issue of this letter
