- (i) The work of “Repairing of Drain in upgradation Colonies (R. K. Colony, Project Colony, Bramsthan Colony and CMWO Laikdih Colony) under CV Area, of BCCL” was tendered vide NIT ref. no. BCCL/CED/TC/e-NIT-13/2015-16/237; dated 23.06.2015.
- (ii) The above work was awarded to you vide LOA ref. no. BCCL/CED/TC/LOA-14/2018-19/698; dated 16.10.2018 at a value of Rs. 41, 57,438.00(Rupees forty one lakh fifty seven thousand four hundred thirty eight only) at overall 6.50 % (Six point five zero percent) below the estimated cost.
- (iii) As per terms of NIT /Tender documents and LOA, you were asked to deposit Rs. 11,65,972.00 (Rupees eleven lakh sixty five thousand nine hundred seventy two only) towards Additional Performance Security Deposit. (Rupees Nineteen lakh seventy five thousand four hundred and eighty only) towards Additional Performance Security Deposit and Rs. 1,63,375.00 (Rupees Four One lakh sixty three thousand three hundred seventy five only) towards Balance amount of Performance Security within 28 (twenty eight) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.
- (iv) However you failed to deposit the Additional Performance Security and Balance amount of Performance Security as per LOA within the stipulated time period of 28 days.
- (v) You were requested several times to deposit the Additional Performance Security and Balance amount of Performance security through various letters as detailed below :



- (vii) As there was no response from you inspite of various reminders issued by the department, the work awarded to you stands cancelled along with forfeiture of Bid Security/EMD of Rs. 44,500.00 (Rupees forty four thousand five hundred only) deposited by you vide DD No. 708007; dated: 29.07.2015 of SBI Govindpur Branch ,for violating the terms and condition of NIT as per clause 4.2 (Condition of Contract) , 4.8(Condition of Contract) and 6.1(Condition of Contract) of NIT.
- (viii) Additionally the following penal actions are invoked against you :
- a. You will not be allowed to participate in the retendering process from the date of issue of this letter.
  - b. You are debarred from participating in future tenders in Bharat Coking Coal Limited for a period of 12 (twelve) months from the date of issue of this letter.
