- (i) The work of "Construction of One lakh Gallons Reservoir and Pump Room with providing and installation of 50 HP Centrifugal Pump motors complete sets with other accessories at Sector-I Koyla Nagar Township under Civil Engineering Department, HQ" was tendered vide NIT ref. no. BCCL/CED/TC/eNIT-07/2020-21/480 ; Date: 10.09.2020.
- (ii) The above work was awarded to you vide LOA ref. no. BCCL/CED/TC/LOA-14/2020-21/590 ; dated: 30.10.2020 at a value of Rs. Rs 24,78,450.31 (Rupees Twenty four lakh seventy eight thousand four hundred fifty and paise thirty one only) which is 37.41% (Thirty seven point four one percentage) below the estimated cost.
- (iii) As per terms of NIT /Tender documents and LOA, you were asked to deposit Rs. 13,98,811.00 (Rupees Thirteen lakh ninety eight thousand eight hundred eleven only) towards Additional Performance Security Deposit and Rs. 74,423.00 (Rupees Seventy four thousand four hundred and twenty three only) towards Balance amount of Performance Security within 28 (twenty eight) days of the issue of the LOA to facilitate issue of the work order and execution of agreement.
- (iv) However you failed to deposit the Additional Performance Security and Balance amount of Performance Security as per LOA within the stipulated time period of 28 days.
- (v) You were requested several times to deposit the Additional Performance Security and Balance amount of Performance security through various letters as detailed below :
 - a. BCCL/CED/HOD(C)/2020-21/679; dated: 28.11.2020.

- (vi) As there was no response from your side despite of various reminders issued by the department, the work awarded to you stands cancelled along with forfeiture of Bid Security/EMD of Rs. 49,500.00 (Rupees forty nine thousand five hundred only) deposited by you vide PRN No. 187813560675 for violating the terms and condition of NIT as per clause 4.2 (Condition of Contract) , 4.8(Condition of Contract), 6.1(Condition of Contract) and 20.2 (Instruction to bidder) of NIT. An office order to this effect was issued vide letter ref. BCCL/CED/GM(C)/2021/11; dated: 06.04.2021.
- (vii) Additionally the following penal actions are invoked against you :
- a. You will not be allowed to participate in the retendering process.
 - b. You are debarred from participating in future tenders in Bharat Coking Coal Limited for a period of 12 (twelve) months from the date of issue of this letter.
