You had been shortlisted as L-1 bidder in both tenders by the system. During technical scrutiny of L-1 bidder, M/S New Diamond Engineering Works, your submitted electrical contractor license & electrical supervisor license was cross checked on <http://electricalinspectorate.jharkhand.gov.in/index.html> & it has been found that these licenses are not authentic and you have forged these papers in your favour.


Your submitted Electrical Contractor License vide ref no- JH/EC/918 belongs to Shri Enamul Haq (M/S Capital Enterprises) & your Electrical Supervisor License vide ref no JH/ES/1977 has permission to operate only up to 650 Volt AC O/H line and not up to 11 KV as mentioned in license submitted by you.

This act of "Wilful Suppression of facts or furnishing of wrong information or manipulated or forged documents" by you attracts following penal actions as per NIT and e procurement guidelines (section 16(2)(vi)) of Coal India Ltd and the same are approved by tender committee;

1. You are being debarred from participating in future tenders of Bharat Coking Coal Limited for the period of 01 (one) year with immediate effect.
2. Your EMD amount against both tenders will be forfeited.
