Dear Sir,

An e-tender notice was floated as referred above. The J V bidder M/s Kallal Logistics had participated in the said tender as a Joint Venture of which you (M/s G N Construction) are one of the member. While examining the bid document & subsequent clarification submitted and reply of the Show Cause Notice submitted by the J V bidder M/s Kallal Logistics, the following have been observed:

1. The bidder, M/s Kallal Logistics, a JV firm has availed the EMD exemption, a privilege specifically intended for a Micro or Small Enterprises under MSME norms. In support of EMD exemption, the bidder has submitted an Udyam Adhaar Registration Certificate (with Udyog Aadhaar no. TN02F0193530) in the name of M/s Kallal Logistics with enterprise type as "Medium" and Date of Incorporation as 20.02.2019.

As the JV agreement of the Bidder, M/s Kallal Logistics, was executed on 20.08.2020, it is evident that the said Udyog Aadhaar registration Certificate doesn't belong to the JV bidder, M/s Kallal Logistics. Subsequent to the requisition of the confirmatory document the JV bidder, M/s Kallal Logistics submitted the following documents:-

- i. A CA certificate certifying that the JV, M/s Kallal Logistics is a small scale undertaking as per MSME norms.
- ii. An Udyog Aadhaar Certificate in respect of M/s G.N. Construction (one of the partner of the JV, M/s Kallal Logistics) with Date of Commencement: - 18.04.2006 and Enterprise Type:- Small
- iii. An Udyog Aadhaar Registration certificate in respect of M/s Kallal Logistics with Date of Commencement:- 20.02.2019 and Enterprise Type :- Medium
