

Project details for External Agencies applying for CSR Project of BCCL “General Duty Assistant (GDA)-advanced” under thematic area of Skill Development for FY 2022-23:

1. Category of external implementing agency

- I. A company established under section 8 of the Act, or a registered public trust or a registered society, exempted under sub-clauses (iv), (v), (vi) or (via) of clause (23C) of section 10 or registered under section 12A and approved under 80 G of the Income Tax Act, 1961 (43 of 1961), established by the company, either singly or along with any other company
- II. A company established under section 8 of the Act or a registered trust or a registered society, established by the Central Government or State Government
- III. Any entity established under an Act of Parliament or a State legislature company established under section 8 of the Act, or a registered public trust or a registered society, exempted under sub-clauses (iv), (v), (vi) or (via) of clause (23C) of section 10 or registered under section 12A and approved under 80 G of the Income Tax Act, 1961, and having an established track record of at least three years in undertaking similar activities.

2. Training for 120 female candidates from operational areas of Dhanbad
3. The external agency needs to have training centre/operational centre in Dhanbad

4. The external agency has to scout the potential candidates, interview/counsel them, select 120 candidates and admit them for the skill development project
5. Placement of successful candidates- as per NSDC norms
6. The External agency/Party has to compulsorily enroll the candidates and initiate training within 20th March 2023.
