Subject : Abeyance of implementation of raising Coal sale bills on GCV based Pricing system w.e.f 1.4.2018

Dear Sir,

CIL Board in its 354th Meeting held on 8.1.2018 accorded its approval for raising coal sale bills on GCV (Kcal/kg) basis w.e.f. 1st April, 2018 or earlier once the requisite system is ready.

Accordingly, CIL & its subsidiaries conducted awareness meeting to make consumers/ stakeholders aware of the new system of billing on 26.3.2018. During consumer meet, number of consumers suggested that CIL should introduce the new GCV based billing system when the proper infrastructure is put in place.

As information gathered during Video Conference held on 31.3.2018, coal companies are yet to achieve the robustness of system and are not fully equipped with proper infrastructure to implement the above system with effect from 1st April, 2018. The VC was attended by Director(F), Director(Marketing) and other Officials from CIL HQ. and D(F), D(T) and other Officials from subsidiary coal companies.

In view of above, the decision to implement "raising coal sale bills on GCV based pricing system" is kept in abeyance till further advice.

The new system shall be initiated at the earliest once the coal companies are geared up in all respect for the requisite system and infrastructure to implement the new system of billing
