Notification for Extension of Last Date for Submission of Application for admission to two Post MBBS DNB seats and for submission of application for one Post MBBS Diploma seat in Central Hospital, BCCL

This is in continuation to the earlier notification with reference No. BCCL/EE/DNB/2022/01 dated 01.08.2022, BCCL Management has decided to extend the last date of submission of Application Form for admission to two DNB Seats for in-service candidate in Central Hospital Dhanbad, BCCL and further notification for one Diploma Seats for in-service candidate in Central Hospital Dhanbad, BCCL

The National Board of Examinations in Medical Sciences (NBEMS) has accredited Central Hospital, Jagjivan Nagar, Dhanbad for Post MBBS DNB in General Surgery, General Medicine and one Post MBBS Diploma in family medicine. The number of seats reserved for In-Service Doctors of BCCL (one for OBC and one for general in DNB course and one for general in diploma course) are as under:-

- 1) DNB in General Medicine – 1 (One)
- 2) DNB in General Surgery – 1 (One)
- 3) Diploma in Family Medicine – (One)

The seats are to be filled by BCCL at its own level from NEET-PG 2022 qualified in-service candidates.

The eligible in-service Doctors of BCCL who have qualified in NEET-PG 2022 may apply for selection against the above seats. The candidates who have got the highest rank in NEET-PG 2022 Examination will be selected.

The eligible candidates should have completed initial probation period and should not reach the age of superannuation from service within 5 years from the date of completion of the course. They should not be long absentees and their VC/DC should be clear. The selected candidates should execute Bond as prescribed.

The eligible candidates should submit their application in the office of General Manager (P/EE), BCCL, Koyla Bhawan through official Dak or through mail at gme.bccl@coalindia.in with supporting documents on or before 5.00 PM of 30.09.2022.
