1. No. of Posts : 25 (Twenty-five)
2. Seizure of Engagement : On expiry of contract period or on attaining 65 years of age
3. Nature of Job : The Contract Medical Practitioners shall be engaged as per requirement of BCCL for conducting PME, daily OPD services and CSR services through Mobile Medical Van or any other duty as may be assigned from time to time.
4. Remuneration & other benefits : The retired Doctors engaged as Contract Medical Practitioners shall be paid honorarium @ Rs.1500/- per day for GDMO and Rs. 2000/- per day for Specialist.
5. Terms and conditions
 - a) The contract shall be for a period of one year from the date of entering into the contract and shall be reviewed on expiry of the contract.
 - b) The CMP shall undergo a medical examination before the contract is entered into for his/her fitness to take up the assignment.
 - c) The retired CIL Doctor engaged as Contract Medical Practitioner shall not have any claim or right for his/her continuity in service or automatic extension of the term of the contract.
 - d) The contract can also be terminated by BCCL and CMP at any time during the contract period by giving 15 days notice from either side without assigning any reasons, whatsoever.
 - e) At the time of entering into contract, the CMP shall produce original certificates for proof of his/her date of birth and educational qualifications.
 - f) Normally the engagement shall be only on weekdays. Apart from normal working hours, the CMPs may be called on emergency as and when needed.
 - g) The CMP shall be posted in Hospital/Dispensary of BCCL as per need.
 - h) Subject to availability, the Company's accommodation will be provided during the period of engagement.
 - i) Any CMP leaving his/her place of work on leave of absence/national holidays should obtain prior permission of the controlling authority.
