Dear Sir,

Your kind attention is invited to the Section 21(2) of Contract Labour(R&A) Act 1970 and Contract Labour(R&A) Central Rules 1971, wherein authorised representative of the Principal Employer is to record under his signature Labour Payment Certificate on the Wage Register of the Contractor workers.

Before certifying payment of wages to the contractor workers, it must be ensured by the Authorized Representative of the Principal Employer that number of attendance of the contractor workers as shown in the Wage Register duly tallies with entry in CLIP PORTAL against the contractor workers.

The authorized representative should also ensure that HPC wages/Minimum wages as prescribed in the NIT/Work Order is being paid by the contractor without which the Labour Payment Certificate should not be issued by the said Authorized Representative of the Principal Employer.
