
In view of above, the management of BCCL has decided:-

To Debar M/s DKS-SKG (JV) and both of its partners i.e. 1<sup>st</sup> Partner of the firm: Dharendra Kumar Singh, PAN No:-AXLPS1937Q and 2nd Partner of the firm: Sanjeev Kumar Ghosh, PAN No:-AKAPG9816G from participation in any tender in BCCL for a period of 3 (Three) years from the date of issue of the letter.**
